Training institutions play an important role in the development of any nation and their role in the implementation of governments' agenda remains unquestionable. # **Key Strategies:**

KMTC should promptly call for a review and update various program curricula to integrate UHC principles, such as primary healthcare, health promotion and disease prevention, into the training programs of various professionals. Community Health and Development is the backbone of many programs offered at KMTC. Students proceed for community diagnosis at various levels of their studies during which they engage communities on several health aspects as they collect data to inform policy making and behavior change communication. For instance;

- 1. Clinical Medicine students undergo training in community health and development for three years. The students engage in community diagnosis activities targeting top priority health needs of the community through health promotion and health education to bring about behavior change towards healthy living. These programs are offered in over thirty-six campuses nationwide. Revamping the program will support the paradigm shift from curative to preventive health care hence reducing the financial burden the government faces in supporting curative services.
- 2. Public health and Environmental health sciences students equally engage communities on promotive, preventive and rehabilitative health services. They educate communities on good housing, environmental sanitation, Water quality and hygiene, food safety, pollution and pollution control, school health, conservancy, communicable and non-communicable disease prevention among others.
- 3. The latest KMTC program i.e., Community Health Assistants (Community health) and Health Promotion are important programs in driving the Kenya Community Health Strategic policy framework (2020-2025) to which the president has committed his support to. Continuous involvement of these students in the community is a key driver towards achieving UHC targets. It is notable that these programs are offered in selected KMTC campuses.

- 4. Health Counselling is a vital program in the rehabilitative and palliative care services. In the contemporary world, everyone is facing mental health challenges. Through supported corporate social responsibility (CSR) students can reach out to communities and reduce the negative and sustained impacts of mental ill-health. Equally, active engagement of these students will help reduce drug use and substances abuse, discrimination and stigmatization of people living with HIV (PLWH), thus fastening the efforts towards the eradication of this pandemic and promoting wellness.
- 5. Nutrition and Dietetics is a very important program in matters nutrition and food security. The engagement of the students in educating the community on food production, preparation and proper consumption will go a long way in promoting healthy living.

All other programs offered at the KMTC are equally important and stand to be counted towards the achievement of the UHC target.

## b. Expanding Student Enrolment

KMTC should continue to seek government's support to expand student enrolment in line with the growing demand for healthcare professionals. Providing scholarships and financial incentives to top students need to be considered to attract more students to healthcare-related courses, especially in marginalized areas.

- c. Infrastructure Development
- 1. Establishing Regional Campuses: To ensure equal access to quality healthcare training, KMTC should establish regional campuses in marginalized underserved areas. These campuses can help train healthcare professionals who are more likely to serve in these regions upon graduation.
- 2. Modernizing Facilities: Upgrading and modernizing KMTC's facilities, including laboratories, libraries, and classrooms, is essential for providing students with the best possible training experience. Public-private partnerships can be explored to fund infrastructure improvements.
- d. Fostering Research and Innovation
- 1. Research Centers of Excellence: KMTC should create research centers of excellence focused on addressing Kenya's healthcare challenges. These centers can collaborate with other institutions and international partners to conduct cutting-edge and evidence-based UHC research.
- 2. Innovation Incubators: Encouraging innovation among healthcare professionals is crucial. KMTC can establish innovation incubators to support students and faculty in developing and implementing creative solutions to healthcare problems.
- e. Monitoring and Evaluation
- 1. Performance Metrics: This concept proposes the establishment of clear metrics to measure KMTC's contribution to the UHC agenda. These metrics should track the number of graduates, their placement in underserved areas, research output, and community engagement activities.
- 2. Feedback Mechanisms: Regularly gather feedback from students, faculty, healthcare providers and other partners to assess the effectiveness of KMTC's initiatives and make necessary adjustments.
- Consultancy: KMTC through this department will engage communities, collect and collate epidemiological data, share information with partners, strengthen UHC system, enhance the utilization of the curriculum, and support staff capacity building in relation to the goal of Universal Health Coverage.




Figure 1: UHC-KMTC Involvement Conceptual Framework
